**REGION 6 CONTEST ENTRY INFORMATION**

**CONTEST ENTRY REQUIREMENTS:**

All entries must be completed **ON LINE** and entry fees sent by mail and postmarked at least thirty (30) days before the first day of competition. See the website for the date of all contests and for the correct deadline for all contests. **The entry fees envelope MUST be postmarked with the mailing date by the post office, and will not be accepted unless postmarked on or before the deadline.** Be certain that all necessary signatures are affixed. Send entries by certified mail with a return receipt requested for your protection. Refer to the current UIL Constitution and Contest Rules for specific entry information. **Form 1's for all contests certifying eligibility of contestants are to be presented to the contest chairman on the day of the contest. No adjudication forms are to be sent through the mail. I will download and print all forms necessary for all contests, including the solo-ensemble contests.**

MARCHING CONTEST: A **“Statement of Compliance”** signed by the director must accompany the fees. For bands in Conference AAA and AAAAA in 2008, you should also include a **“Letter of Intent”** signed by your principal or Superintendent to advance beyond the Region competition to the Area Marching contest, if that is your intent. If you have twirling entries, please fill out the appropriate forms for that contest, which will be held on the same date as the Region 6 Marching Contest.

**CONTEST ENTRY FEES:**

- Marching Bands..... \$300.00 per organization – This amount covers all fees and recordings
- All Varsity Concert Groups..... \$300.00 per organization – This amount covers all fees and recordings
- All Non-Varsity Concert Groups... \$300.00 per organization - This amount covers all fees and recordings

**LATE FEE FOR ALL ORGANIZATION EVENTS IS \$100.00 PER ORGANIZION**

Solo-Ensemble Fees ..... \$8.00 per student member of each group or solo

**LATE FEE FOR SOLO-ENSEMBLE CONTESTS IS \$33.00 PER PERSON - \$25.00 + \$8.00 ORIGINAL ENTRY FEE**

**CHOIR DIRECTORS:** Be certain that you have indicated the number of students in each concert choir you enter PLUS indicate the voicing that you will be using for sightreading. **ALL CLASS BBB VARSITY TREBLE CHOIRS MUST SIGHTREAD SSA.** Refer to the current Constitution and Contest Rules, Section 1111 for further information regarding choral sightreading procedures. See the website listed above for on line access to this information.

**An invoice form is on the website for your convenience and for your Business Office.** Please download the form and use it to tabulate fees and make check requests for your school district. **This form should also be used as an invoice for payment to UIL Music Region VI.** PAY CLOSE ATTENTION TO THE TABULATION OF YOUR FEES. Overpayments of \$20.00 or less are not refundable. Fees are to be paid by CHECK (no personal checks and no cash) and the **check is to be made payable to: REGION VI MUSIC EXECUTIVE COMMITTEE.**
