UIL ENTRY FEES

The state UIL office has raised judges' honorariums for the 2007-2008 school year which will result in our having to raise entry fees again this year. Here are the fees I propose:

ALL ORGANIZATION ENTRY FEES INCLUDE APPROPRIATE STATE AND RECORDING FEES. (State Fees are as follows: Marching Bands \$10, Varsity Concert Groups \$15, Non-Varsity Concert Groups \$10) (Recording Fees are as follows: Marching Bands \$30, Choirs \$35, Orchestras \$40, Middle School Bands \$35, High School Bands \$40)

Twirling	\$15 each solo, \$15 each ensemble member
Solo & Ensemble	\$8 each solo, \$8 each ensemble member

JUDGES HONORARIAM AND TRAVEL EXPENSES

MARCHING, CONCERT, SIGHTREADING

Region 8 pays the state suggested rate of \$250 per day and \$50 per hour overtime for contests lasting longer than eight hours.

SOLO AND ENSEMBLE

Region 8 pays the state suggested rate of \$200 per day and \$37.50 per hour overtime for contests lasting longer than eight hours.

All judges will be reimbursed for mileage at the rate of \$.585 per mile.

Necessary lodging will be arranged and paid for by the region.

A per diem for meals not furnished by the contest host will be paid at the rate of \$8 for breakfast, \$12 for lunch, and \$16 for dinner.
